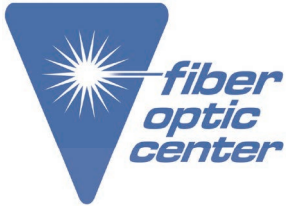

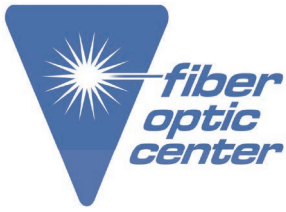

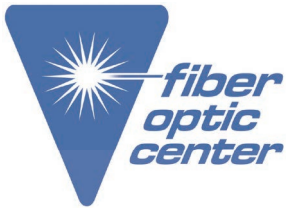

## Section 5. Fire-fighting measures

### Extinguishing media

## Section 7. Handling and storage

### Precautions for safe handling

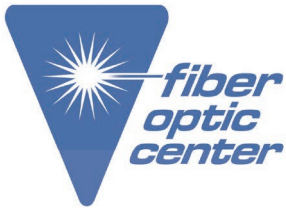

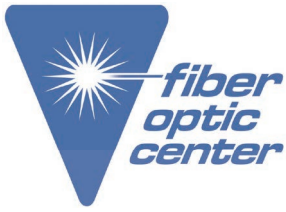
