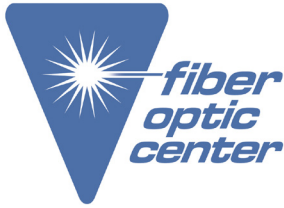

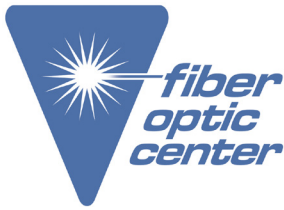

Section 6. Accidental release measures**Large spill**

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Section 8. Exposure controls/personal protection

Appropriate engineering controls : Use only with adequate ventilation.
